AUTHOR'S EXPERIENCES: THE WRITING OF BENNION FAMILY VOLUME 4

Many touching and, yes, miraculous things occurred in relation to researching and writing the book. Lucile Dimond Smith. daughter-in-law of President Joseph F. Smith and Utah Mother of the Year, had 23 journals in her possession containing valuable information written by older Bennions. Over the years various Bennion committees had tried to convince her to release the journals. She was in her eighties when I contacted her. The first five times I made appointments with her and called in advance to remind her, she cancelled. Finally I made an appointment and decided to go without reminding her. I took down the wire gate that led down a long lane to her house. It was close to noon and very warm. Lucile had just returned from a funeral, had forgotten the appointment, and was not in a mood to talk to this stranger.

I had written a history of our greatgrandmother Esther Wainwright Bennion and, with help from the Morrison family in Vernal, had located a picture of Esther when she was young. I said to Lucile, "I have something for you. Let me come in and wait while you have your lunch. I'll give you what I have, then leave if you want me to."

I sat in the living room where I could see out of her kitchen window. She ate, came in, and was surprised and delighted by the picture, which she could remember from her childhood home. She began reading the history. Suddenly she laid it on the table beside her and walked to the kitchen window, where she stood while the minutes ticked away. I saw her shoulders shaking. When she turned there were tears streaming down her face. She said, "You're the one."

"I'm the one what?" I asked. She explained that her grandfather, Samuel R. Bennion, had given her the journals and said, "I

don't suppose you'll do anything with these, Lucile, but you'll know who to give them to when the right person comes along."

I managed to hold back the tears while she gave me a few of the journals from the ornate little trunk that had held them all these years. But when I pulled through the gate, I stopped and the tears flowed. As I copied and returned the journals, I gained her trust, and eventually she gave me the whole collection with the request that the journals be donated to the BYU Archives. Among them was the original book John Bennion carried on his genealogical mission to England and Wales. One-third of the way through an account book I found the missing Muddy River Mission Journal.

SAMUEL BENNION'S WILL

[Below is a transcription of Samuel's will, which is registered in the Salt Lake County Recorder's Office. No will for John Bennion is found there. Thanks to Helen Madsen, as usual, for providing this interesting piece of heritage.]

"In the Name of Jesus Christ - Amen!
Be it known by these present that I, Samuel
Bennion - of North Jordan in the County of
Salt Lake and Territory of Utah, being of
lawful age, to wit, Seventy years of Age, and
of Sound Mind and Memory, though feeble in
body and realizing the uncertainty of human
life, and desiring to dispose of my Estate
according to my own pleasure and best Judgment, do by these present, make, publish and
declare this instrument in writing by me
subscribed to be my last Will and Testament
and:

- "1. First: I direct that the expenses of my last sickness and funeral and then all my just debts and liabilities be paid and discharged out of my personal estate.
- "2. Second: I give and bequeath to my beloved wife, Rhoda Jones Bennion, in liew of Dower right for her sole use and benefit, a life interest in my Homestead and Farm except as hereinafter provided, with the rents, issues and profits arising therefrom. Also the dividents and profits arrising from the following specified shares of stocks, to wit: Twelve shares of the Capital Stock of the Deseret P[illegible] of Salt Lake City: Forty Shares of the Capital Stock of the Home Fire Insurance Company: and Ten Shares of the Capital Stock of Zions Co-operative Mercantile Institution for and during the term of her natural life. Also, absolutely and without condition All Household and Kitchen furniture, beds and bedding and all poultry and hogs of which may be possessed at the time of my demise. Also a wagon, Two buggies and a sett of harnesses.
 - "3. Third I give and bequeath to my son,

Wilford Bennion out of my farm Thirty-acres of land situated in the South West corner of my farm and bounded on the South by land owned by George M. Spencer and on the East and West sides by County Roads and on the North by land heretofore de [illegible] and to my son, Joseph Bennion

"Fourth: I give and bequeath to my son Arthur Bennion the sum of One Thousand Dollars. These last two bequests being made to bring the dowry to an equality with my other children to whom advancements have been already made.

"Fifth: I give and bequeath to John Jones a son of my said wife [Rhoda Jones by her first marriage], the sum of One Hundred Dollars, to be paid within Ten days after my decease

"Sixth: I have sold to John A. Sharp and his wife, Rebecca Ann Bennion Sharp, who is my Daughter, about One hundred and Twenty Acres of Land for the consideration of Four Thousand Dollars, but for which at the signing of the instrument in writing and Deed of convayance has been executed and delivered, for which the said Sharp is to pay me Two Thousand Dollars in money. The remaining Two Thousand Dollars I give and bequeath to my said Daughter - Rebecca Ann as follows: One Thousand dollars as an advancement, and the other One Thousand as a part of the bequest hereinafter made to her as one of the [illegible] under this will.

"Seventh: The names of my children are as follows: John R. Bennion, Hyrum Bennion, Joseph Bennion, deceased, Emma Bennion Lindsey, Samuel Heber Bennion, Rebecca Ann Bennion Sharp, Alice Jane Bennion, Wilford Bennion and Arthur Bennion to whom I give and bequeath all and singular the residence and remainder of my estate, share and share alike. Sir Henry Guy was also the head of Britain's Institution of Mechanical Engineers until his retirement in 1950. Guy Dear, in turn, is a grandson of Laday Margaret and Sir Henry. Guy's mother and Sir Henry's daughter, Joan Dear, has been a good friend of many U.S. Bennions who have visited England in search of our roots. those who are dead to take the share of the parent by right of representation. Should any of my said children die without issue before final distribution such deceased share to be divided equally between the surviver and the children of those who are dead. I hereby nominate and appoint Samuel Bringhurst, Archibald Frame and William Panter or the survivors of them Executors of My Estate and of this my Last Will and testament without bonds. As witness my hand this twenty-eighth (28th) day of August Eighteen Hundred and Eighty Nine A.D. 1889

"Be it known that the undersigned have herewith set our hands as witnessess to the signing of the foregoing instrument in writing and certify that the said Samuel Bennion signed said instrument in our presence and that we signed the same in his presence and at his request as witness thereto and signed the same in the presence of each other and that at the signing of said instrument in writing he, the said Samuel Bennion declared and published said instrument in writing as and being his last will and Testament in our presence and to us. As Witness our hands the date of said instrument a [illegible] set forth. [illegible]

MORE FAMILY GROUP SHEETS!!

We are indebted to Helen Madsen, our family genealogical coordinator, for her diligent efforts in documenting the genealogical work that has already been done. The purpose of this Herculean effort is to make your personal efforts more efficient by eliminating the need for duplicate research. Our objective in the coming issues of the Recorder is to provide documentation all the way to the ends of the known family tree, so we can all concentrate on original research.

Hopefully you are saving the past issues of the Recorder, so that these family group sheets don't get too confusing. In the last issue (December, 1990) we published a pedigree chart that started with the pioneers Samuel and John's father, John Bennion Sr. (1786-1846) and went back three more generations. In this issue we follow the Griffith line back two more generations, and reach the currently known end of these lines. By comparing the pedigree chart in this issue to the one in the December 1990 issue, you should be able to figure out where we are.

As in previous issues of the Recorder, we have followed the convention of only including documentation of the earliest ordinance date that is properly documented. This explains why sometimes ordinance dates seem out of order. We hope our documentation efforts eliminate future duplication. For more complete documentation, please contact Helen Madsen.

Please note that there is no documentation for the family of Mr. and Mrs. Griffith, the parents of Edward (born about 1690). This is because the existence of this family was deduced using estimating procedures allowed by the LDS Church Family History Department.

We are grateful for Helen's dedicated work in this area, but she is very anxious to share the blessings! We need help in two areas: (1) double checking work that has already been done so that we can be reasonably certain of publishing accurate information, and (2) original research. No experience necessary, and great eternal paychecks!

For the time being please use the pedigree charts and family group sheets in The Recorder as your source for the most accurate information we have on John Bennion & Elizabeth Roberts and their ancestors.

LETTER FROM MARY TURPIN BENNION

[The following letter, written by Mary Turpin Bennion, is an example of the material found in Bennion Family Volume 4. Mary Turpin was the third wife of John Bennion, and Heber was their eldest son. Enoch was the eldest son of John and his second wife, Esther Ann Birch. Samuel R. was the eldest son of John and his first wife, Esther Wainwright. Alfred was the second son of John and Mary. At the time of this letter, John was 53 years old, Mary T. was 32, Samuel R. 31, Enoch 15, Heber 15, and Alftred 12. The family of John and Esther Ann had returned from their Muddy River Mission 11 days earlier.]

West Jordan Dec. 1 [1873]

Dear son Heber

it seems a hard task for me to inform you of the sudden death of your much beloved brother Enoch it seems verry hard for us to part with him no one could tell the feelings of his poor Mother I never saw your Father feel so bad before this is the eleventh day since your Father got home with his family all on the sunday he had twelve sons in school we had the missionarys and had a very good meeting monday and tuesday Enoch was helping the boys haul manure wensday morning he went with Samuel R. and Alfred after coal to coalsville expected to get home on friday in the after noon on friday your Father started to the factory and met Samuel a little ways past callders but with no coal when Sam saw his Father he wept like a child he said Father just look under the blanket and there lay Enoch cold in death vour father hasten home to bring the sad news while Sam came slowly on they had started before daylight that morning with thir loads with Enochs team in the midel they where all walking the lines tied up comeing down a they whent on the off side to put little hill on the brak when the two teams run down the hill Alfreds team runing past Enochs Alfred

run to stop the team they stoped at the foot of the hill and looking back they saw Enoch he could not speak laying in the road lived about ten minutes Alfred went back to the settelment with the 2 teams he started home the next day with Bro Wardel got home yesteday when he met Enochs funerel took a horse and followed them vour Father and Alfred started this morning after the 2 loads that was left forty miles your father told me to write to you to say [he had?] intend to send Israel to the sheep to let you come in now he as lost Enoch he would not send Isreal away and you will have to stay until he can hire a boy. I am sorry you was not here to see Enoch I feel anxous for you to go to school Isreal wants you to come home may the Lord open the way for you to come and comfort your heart and give you wisdom to do your duty. your Father is comeing out soon do write soon as you can


