

## Bi-annual Reunion Slated for August 22, 1992

The Bi-annual Bennion Family Reunion has been scheduled for Saturday, August 22, 1992 from 4:00 p.m. to 7:00 p.m. at the Taylorsville Stake Center, 1400 West, 4700 South, Taylorsville, Utah. The featured speaker will be our own Lowell L. Bennion, health permitting. Lowell, now in his 83rd year, is both a grandson of John Bennion and a great grandson of Samuel! Come to the reunion to learn the details. Lowell is a renowned and much honored educator, author, speaker, and humanitarian.

Also featured will be the recently restored sheep wagon of Samuel R. Bennion, the eldest son of John. The wagon was originally constructed in between 1867 and 1870, probably by Samuel R. with the assistance of William Turpin, the father of John's wife Mary Turpin. The wagon is currently undergoing restoration at Pioneer Trail Park at the mouth of Emigration Canyon in Salt Lake City, next to the "This is the Place" monument and where the wagon will be on permanent display. The park rangers have assured us that we will be able to borrow the wagon for our reunion, assuming the restoration is completed on schedule.

Assuming you are a great grandchild of one of them (like I am!), then John Bennion, born about 1663, is your sixth great grandfather! Thanks to the efforts of our family genealogists nonpareil Helen Madsen and the late Howard S. Bennion, we are pleased to present the will of this John Bennion, born in about 1663, for your enjoyment, enlightenment, and edification. Please note that this John Bennion had a wife Alice and a daughter Alice. Although we don't have a death date for Alice the wife, the tone of the will suggests that she had preceded her husband in death. Also note that this John's eldest son John is our direct line ancestor (my fifth great grandfather). Son John was 24 years old at the time of his father's death and had been married to Susannah Baxter for about six months. —Ed.

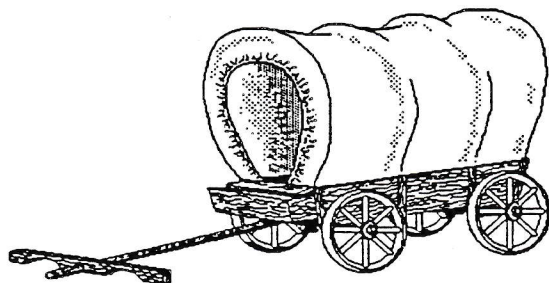

## BENNION FAMILY VOLUME 2 UPDATE PLANNED

---

Those of you fortunate enough to own copies of Bennion Family History Volume 2 know how valuable it is in identifying your Bennion relatives and locating them on the family tree. The book was published in 1963 and contained all known Bennion descendants as of that date, grouped by families and well-indexed for easy reference.

Computer technology has made it feasible for us to tackle the daunting task of updating that book. Our Family Computer Coordinator, Steve Bennion, is maintaining the database, which now contains over 2100 families and over 8000 individuals. While Steve does an excellent job of keeping the computer files accurate, they are only as complete as the information he receives. We suspect that more than half the Bennion descendants are missing!

The only family tree "branch" that is believed complete is the one descending from Rebecca Ann Bennion Sharp. This "branch" is available for \$3.50, as shown on the order form on the last page of this Recorder issue. Helen Sharp Madsen, who has spearheaded the effort to document this line of Bennion posterity, says that any additions or changes are always welcome -- this is a *living* tree!!

In order to publish a reasonably accurate and complete update to Volume 2, we desperately need volunteers to check portions of the family tree database for accuracy and completeness. Please contact Steve and he will send you whatever portion of the tree you can help with — perhaps all descendants of you and your spouse, or your parents, or your grandparents.

If you've been wondering what you could do to help but are afraid of research and/or computers, **HERE'S YOUR CHANCE!!!** When this new version of Volume 2 is printed (hopefully soon), your name will be in lights in the acknowledgements!! Steve's address is on the back page.

# Will of John Bennion (1663)

“ESTATE OF JOHN BANNION OF MANCOTT, the less, in the County of Flint, deceased, 1714. Will of John Bannion of Mancott the less in the County of Flint, Senior, yeoman. Dated 20 April, being Tuesday, 1714.

“Being sick and weak in body, etc. All debts and funeral expenses to be first paid and discharged. Testator directs that all of his cattle and utensils of husbandry be divided between his loving son William and his (testator’s) three daughters, Alice Ann and Jane.

“Unto my said son William the house in Hawarden which Alice Barnes now liveth in together with the ground, barn, backhouse and all appurtenances during the term of his life (as it stands on the backside of his brother, my son John’s assignment out of the original lease) Also to testator’s said son William certain household goods, the said William to provide for his (William’s) three sisters Alice, Anne and Jane, whenever they are ill or in ill plight during the time they are minors.

“The testator gives to his daughter Elizabeth his house in Hawarden Commonly called Riscoe’s House with all its profits and advantages that shall accrue.

“I give and bequeath to my eldest son John the sum of one shilling.

“To Alice the cow even now called hers known as Nutt or Nutty.

“To Ann the black heifer called lovely.

“To said daughters Alice and Ann certain cattle, and the remainder of his farm stock to be divided equally between William, Alice and Jane.

“To his said three daughters the beds, feathers, other furniture and all brass and pewter.

“All increase of the Mancott farm to be divided equally between William, Alice, Ann,

Jane and Elizabeth.

“To William all the bricks that are in the brickkiln now standing and being in the field, croft or enclosure on ye backside the house in Mancoatt I now inhabit for his sole use and behoof.

“Everything else was to be divided between Alice, Anne and Jane.

“The testator appoints his son William and friend and brother-in-law John Street of Manor joint executors.

“WITNESSES: Richard Brooke, Mary Ledsham, Hu: Thomas, “The Schoolmaster.” Proved by both executors, 27 April, 1714.”

*The following comments were written by Howard Sharp Bennion:*

“Picture for a moment the difficult situation of the oldest son, the heir by the terms of his father’s lease from the landlord, Thomas Ravenscroft, to a valuable lease hold. Cut off with one shilling, taking over the property in the Spring season, the leasehold stripped of everything that could be taken from it—every last animal, implement, tool, utensil, furnishing, all the stores and provisions and even the crops to be harvested in the coming summer and fall. Undoubtedly a dying father’s concern for the future of four unmarried daughters ranging in age from 9 to 18, contributed to this death-bed decision to revoke his previous will and spell out in detail the drastic terms of this last will and testament. Perhaps also there was a shrewd idea that a rich father-in-law would tide his son John over the difficulty by furnishing money or credit to buy at a good price the livestock, implements, tools and other much needed items from the legatees. The inventory showed practically no cash. Usually a father or mother expecting death had converted considerable property into liquid

assests for distribution. But the language and provisons of the testament indicate considerable ill will.

“At about the age of 23 in October 1712, the oldest son John, heir to the leasehold, had married Susannah, daughter of a well-to-do yeoman, Thomas Baxter with a leasehold at Chorley, Backford parish where he lived and a second leasehold at Capenhurst, Shotwick parish, both in Cheshire, across the Dee River from Hawarden parish. Susan kept house for her father, a widower of a few months, and John and Susan made their home with him. Their first child, John, born there in August 1714, was taken to the Mancott home and died and was buried in Hawarden Churchyard November 29, 1714. A daughter Mary, another son John were born and died at Mancott. A second Mary was born there. Then a third John was born and died. In the meantime Susan’s father had turned over his Chorley place to his oldest son and moved to his Capenhurst holding. Perhaps disheartend by the loss of four children, John and Susan moved to Capenhurst for the next few years. Their second Mary died at Capenhurst in 1723 bringing their loss to five, but the four children born to them in Capenhurst survived. They were John, born August 8, 1823, who became our ancestor, Then William, Jane and a third Mary, born in 1733.

“In the years following his sojourn in Capenhurst until his unrecorded death about 1746, John Bennion served on a king’s jury to survey the lower Dee River between Chester and its mouth and redetermine that section of the Welsh-English boundary. He served also on one or more committees to survey the conditions of the poor and recommmeded measures to be taken. His signature in his own hand appears on a map and on documents now in the library of the Flint County Record Office at Hawarden. His widow, Susannah lived during her widowhood in Pentrobin

township of Hawarden parish. She died in 1755 and the letter of adminstration of her belongings revealed that she was in modest circumstances.

“What of William and the four daughters? William, who was 21 when his father died, married in 1718 Margaret Howell and had several children. He resided in Bannell township of Hawarden parish and his name appears in the records indicating that he was a man of responsible affairs as was his son William after him. William Senior died in 1744 and his widow in 1758. Anne, the second in the list of four daughters in the 1714 will of John Bennion married Daniel Ledsham in 1719. The Hawarden parish register does not show or indicate that Alice, Elizabeth or Jane ever married. There is no indication in any of the records of ill will between the eldest son John and his brother and sisters.”

## Ancestral File Corrections

---

If you use the Ancestral File available at LDS Church Family History Branch libraries throughout the world, you know both the good news and the bad news. The good news: you can access and obtain information on over 2,000 of your Bennion ancestors, and easily “paste” the information into your personal family tree. The bad news: the data is not 100% accurate.

The church updates these files on a regular basis, usually once or twice a year. The next update is due out this summer. The church has asked that families submit corrections in an organized fashion—not hundreds of people submitting the same corrections. If you note problems in the Bennion tree (including Roberts, Iball, etc.), please notify Helen Madsen, as she is our representative for submitting corrections. OK? OK!

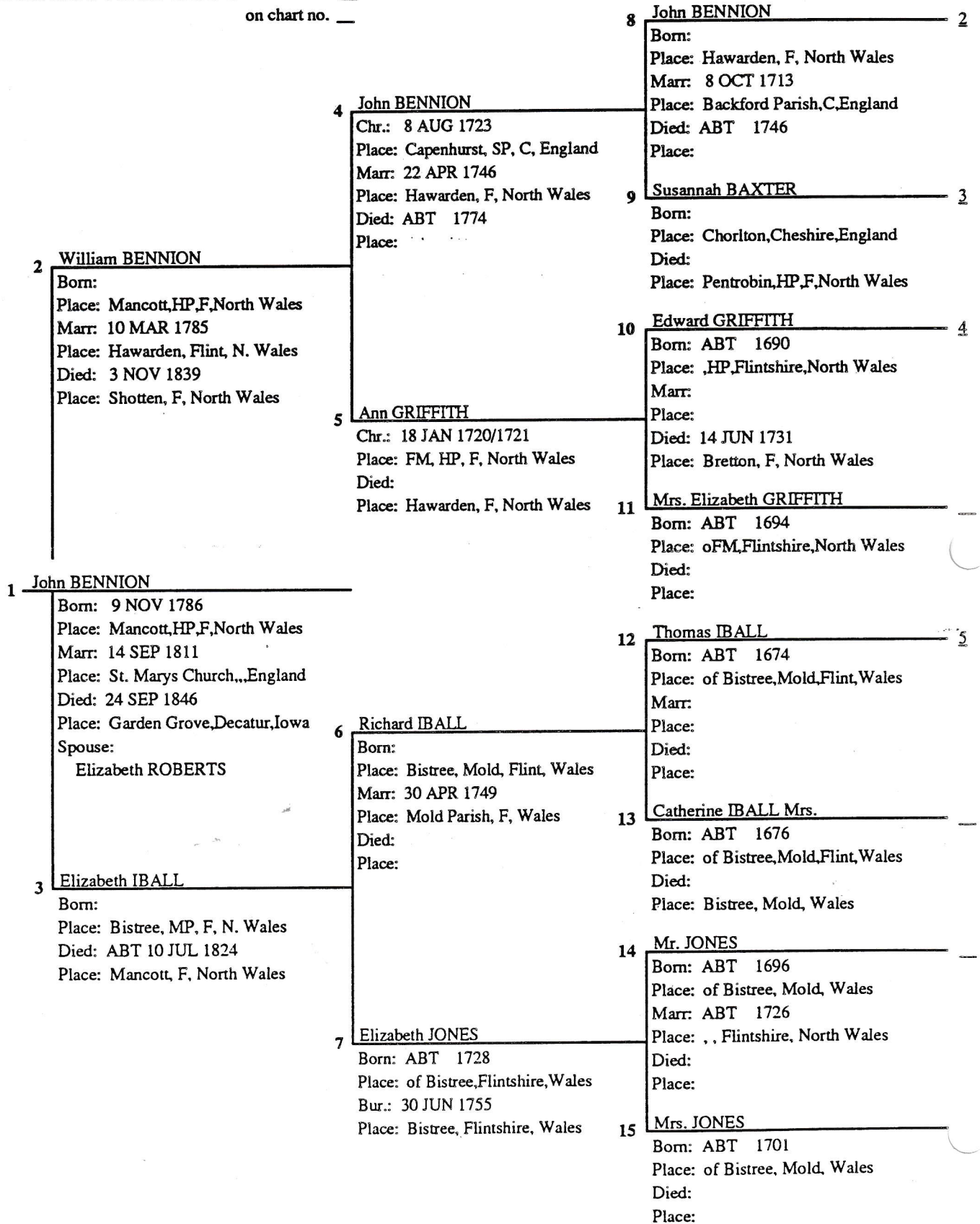

PEDIGREE CHART

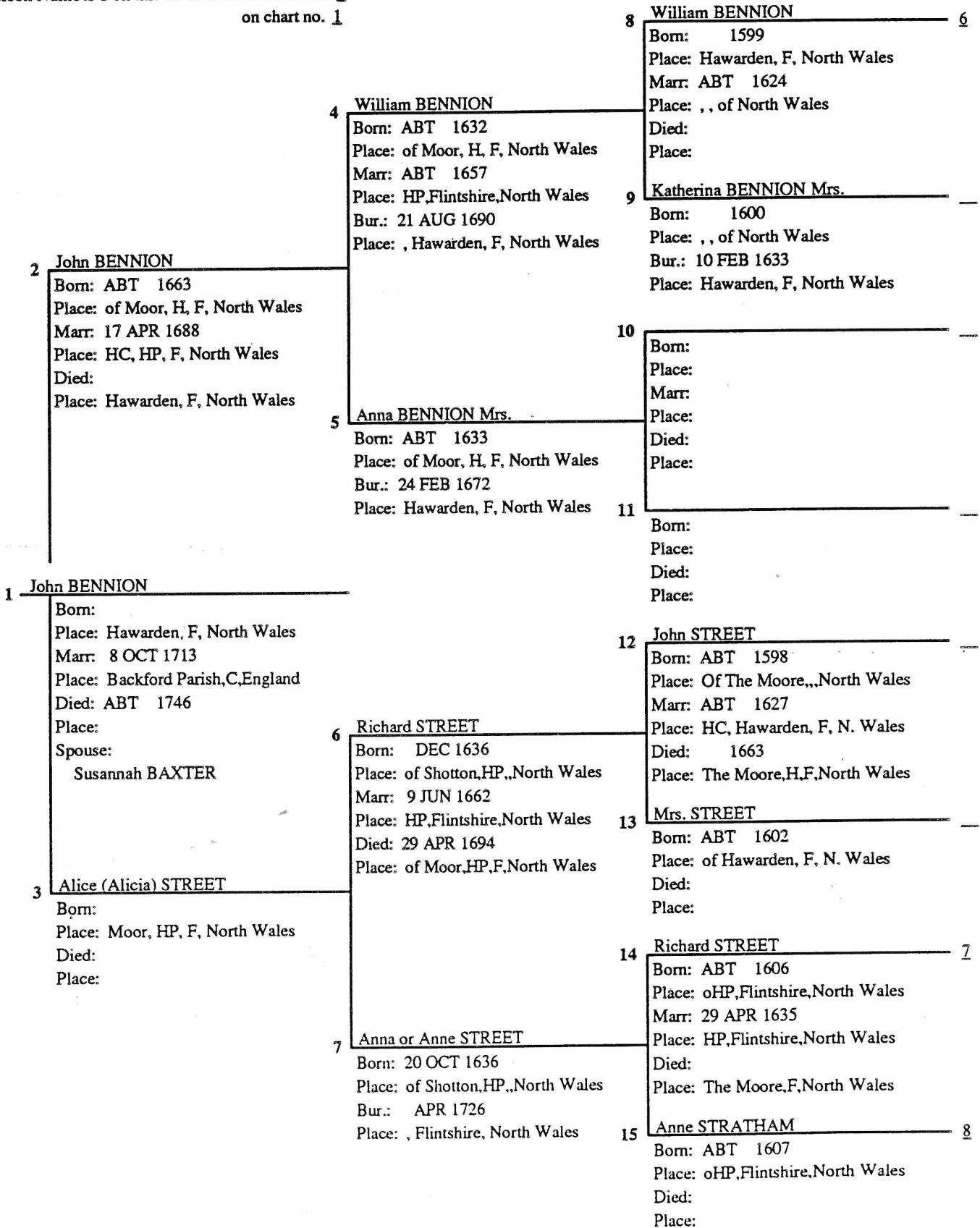

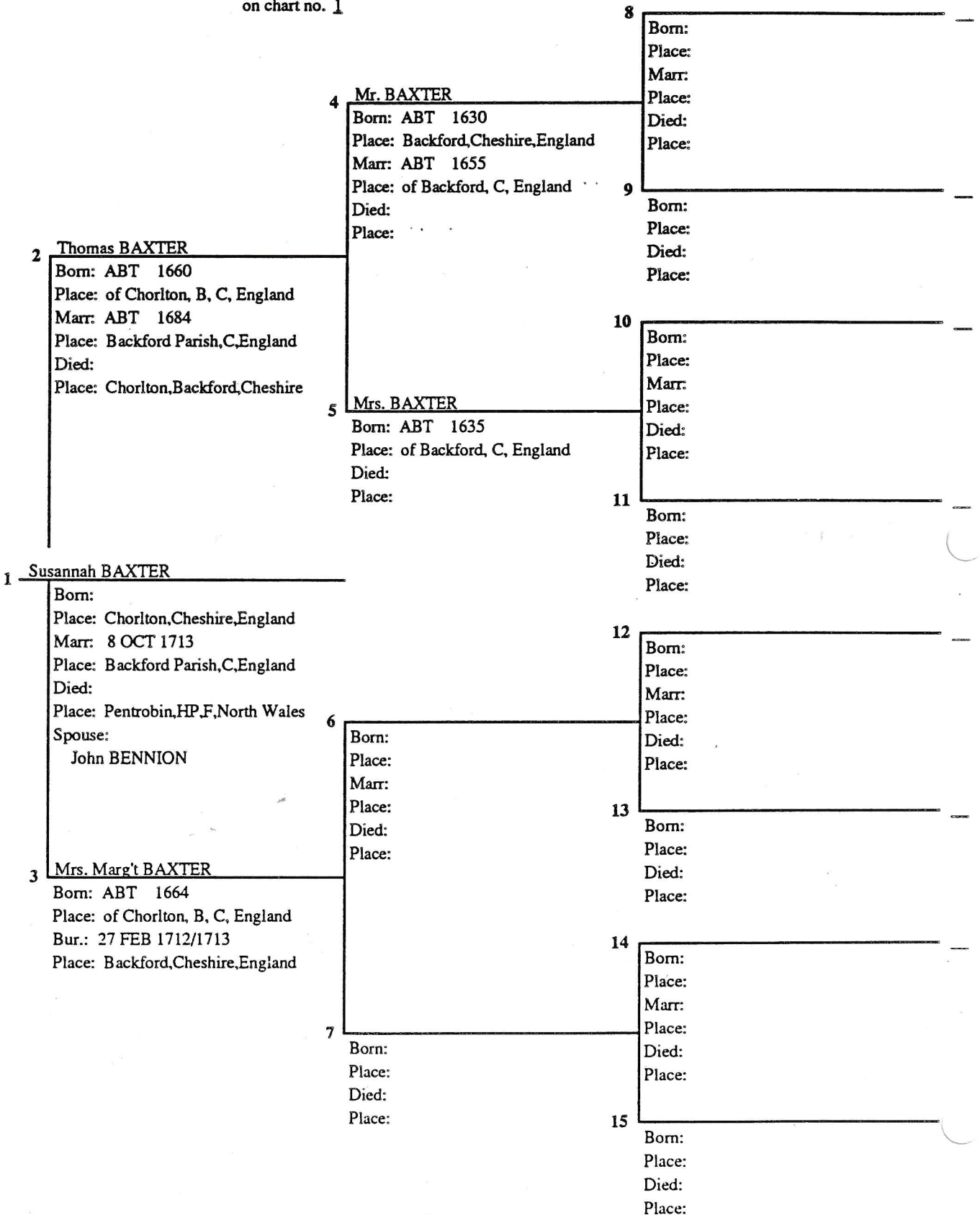
PEDIGREE CHART

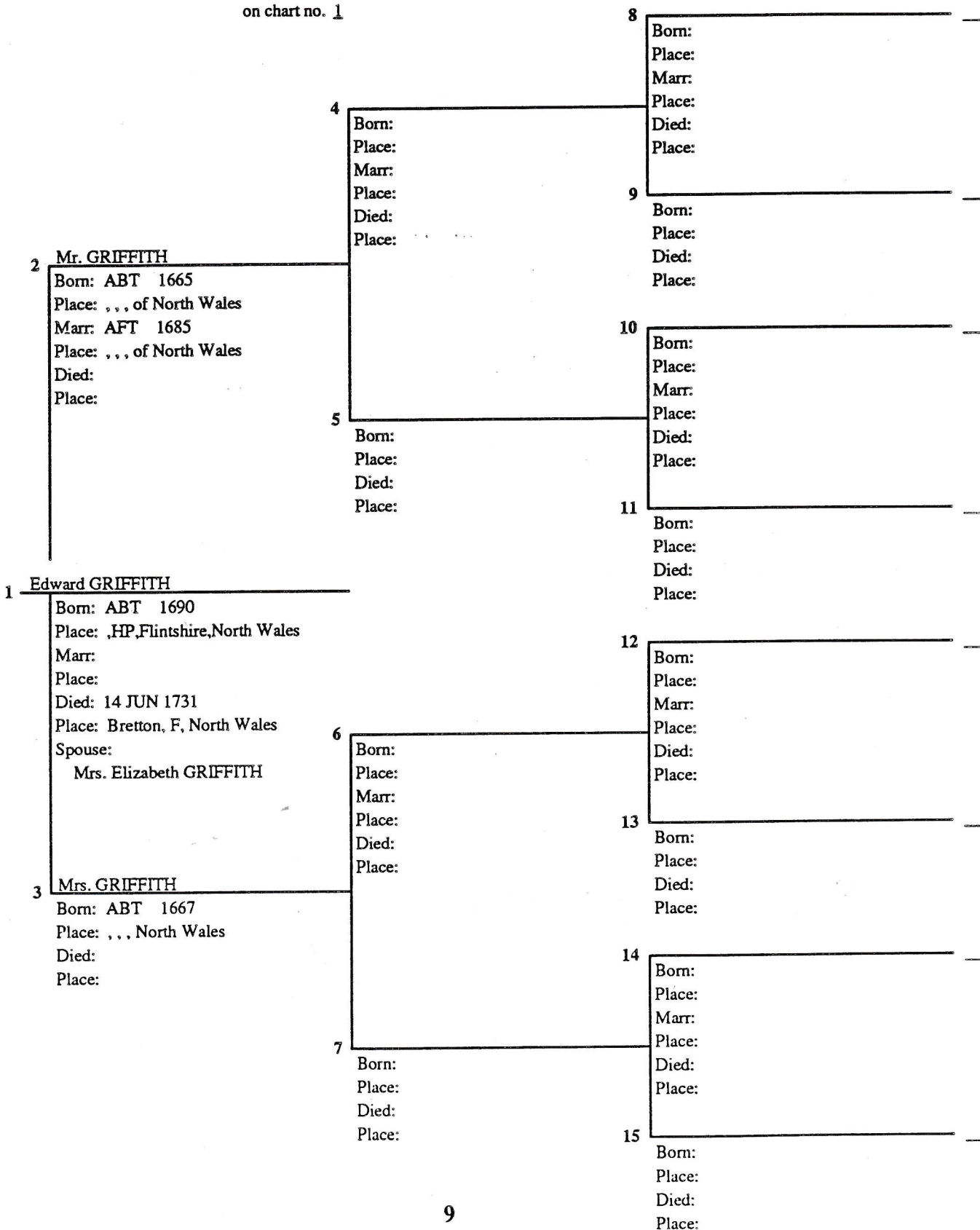

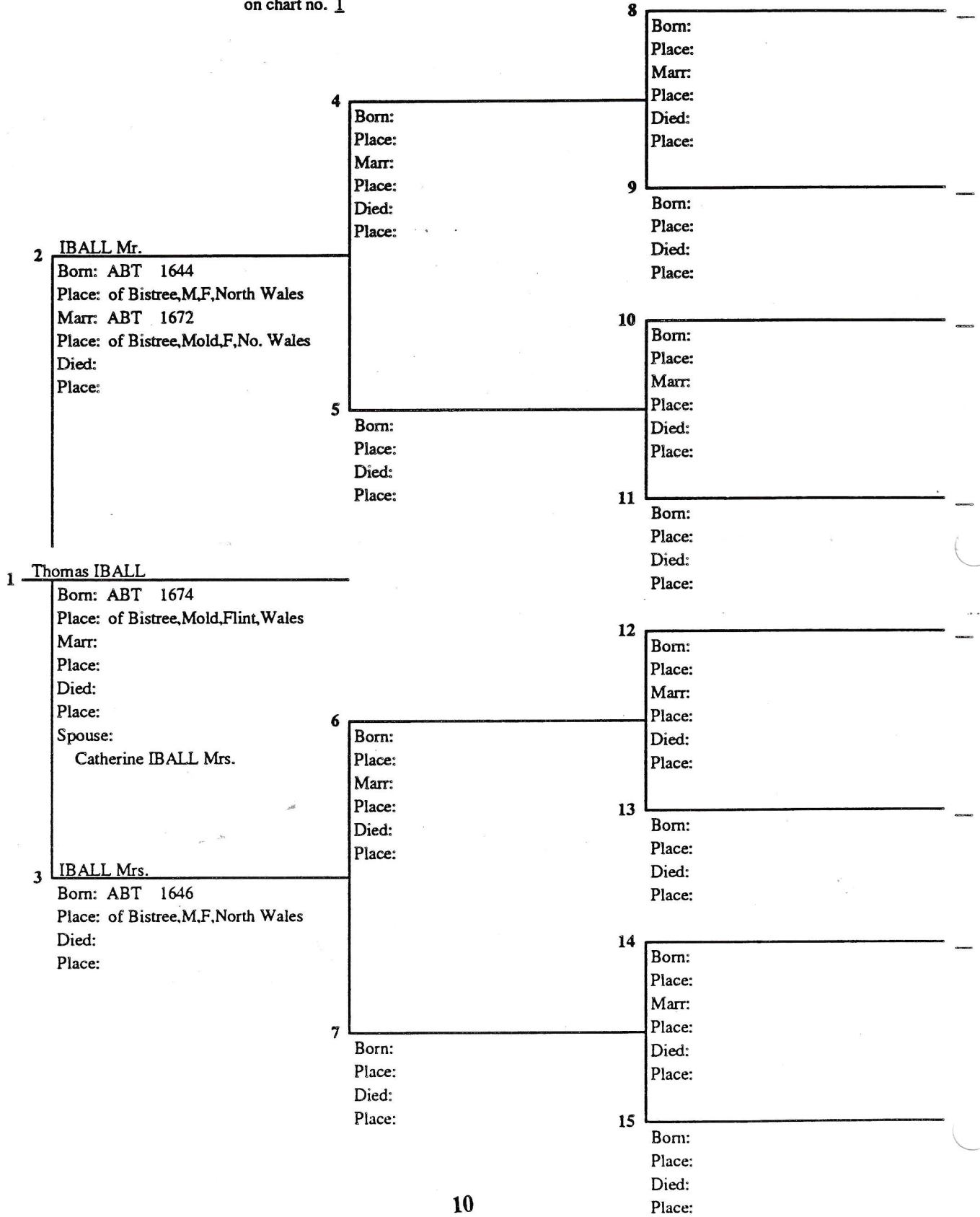

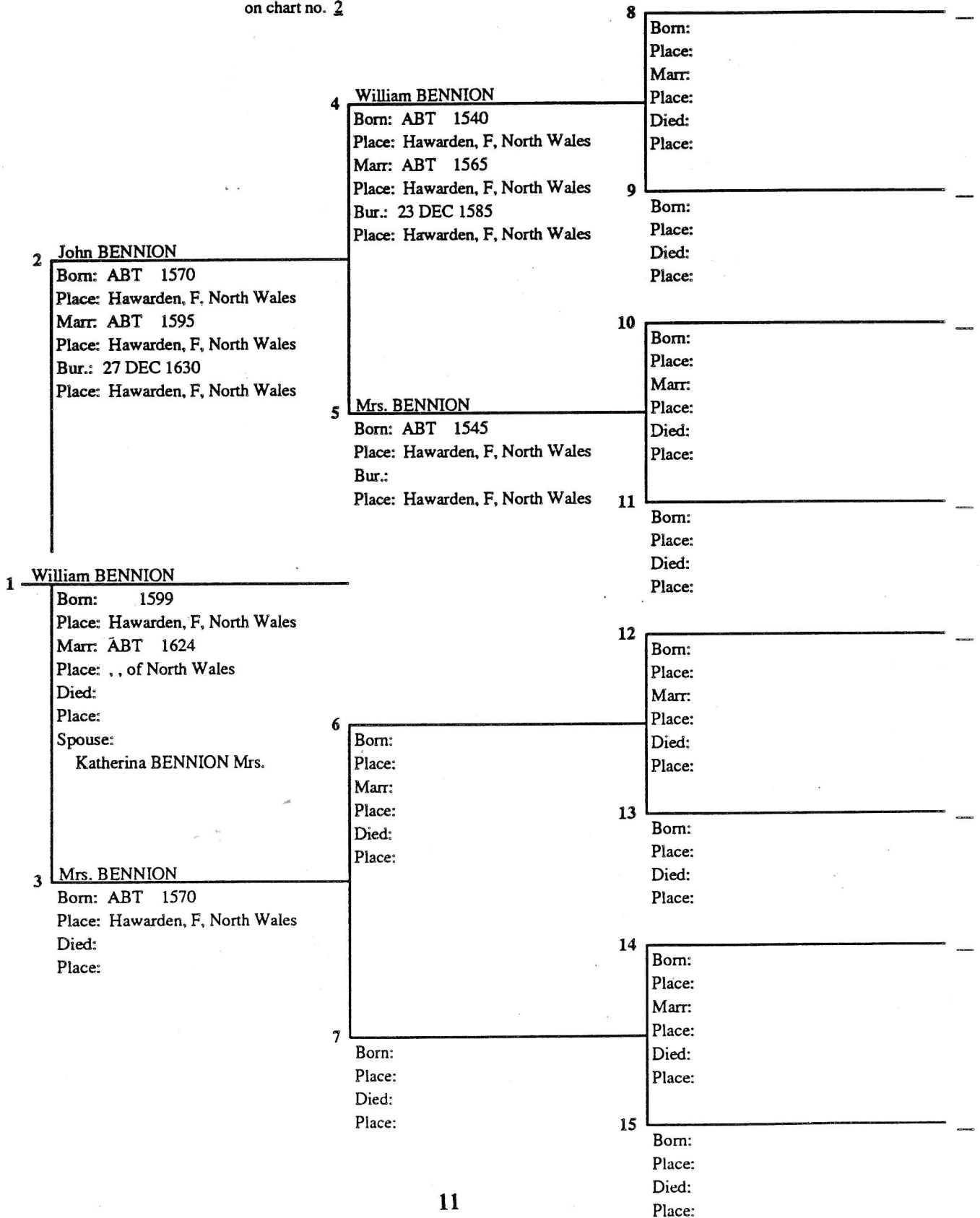
PEDIGREE CHART

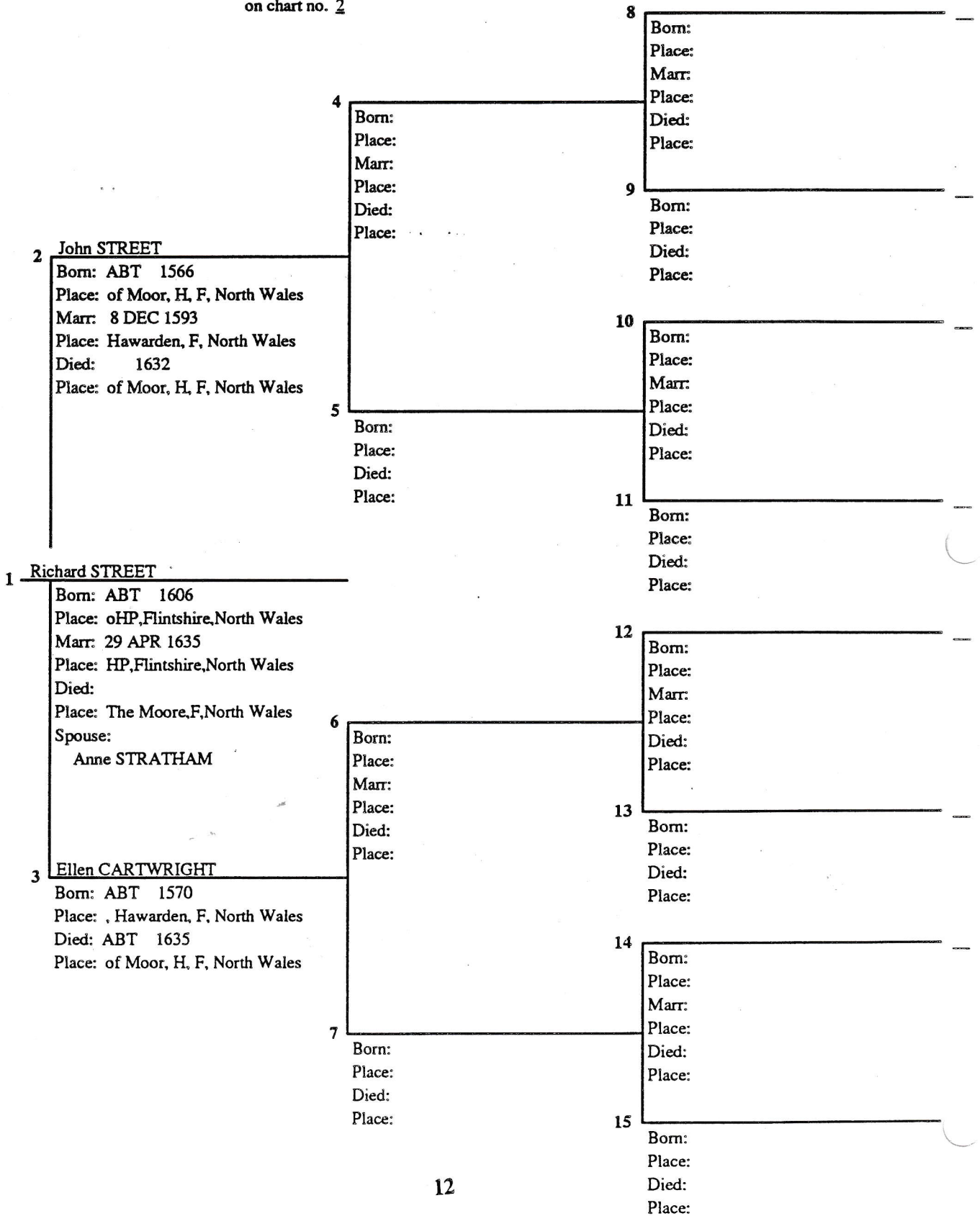
Person Number 1 on this chart is the same as no. 8

# PEDIGREE CHART

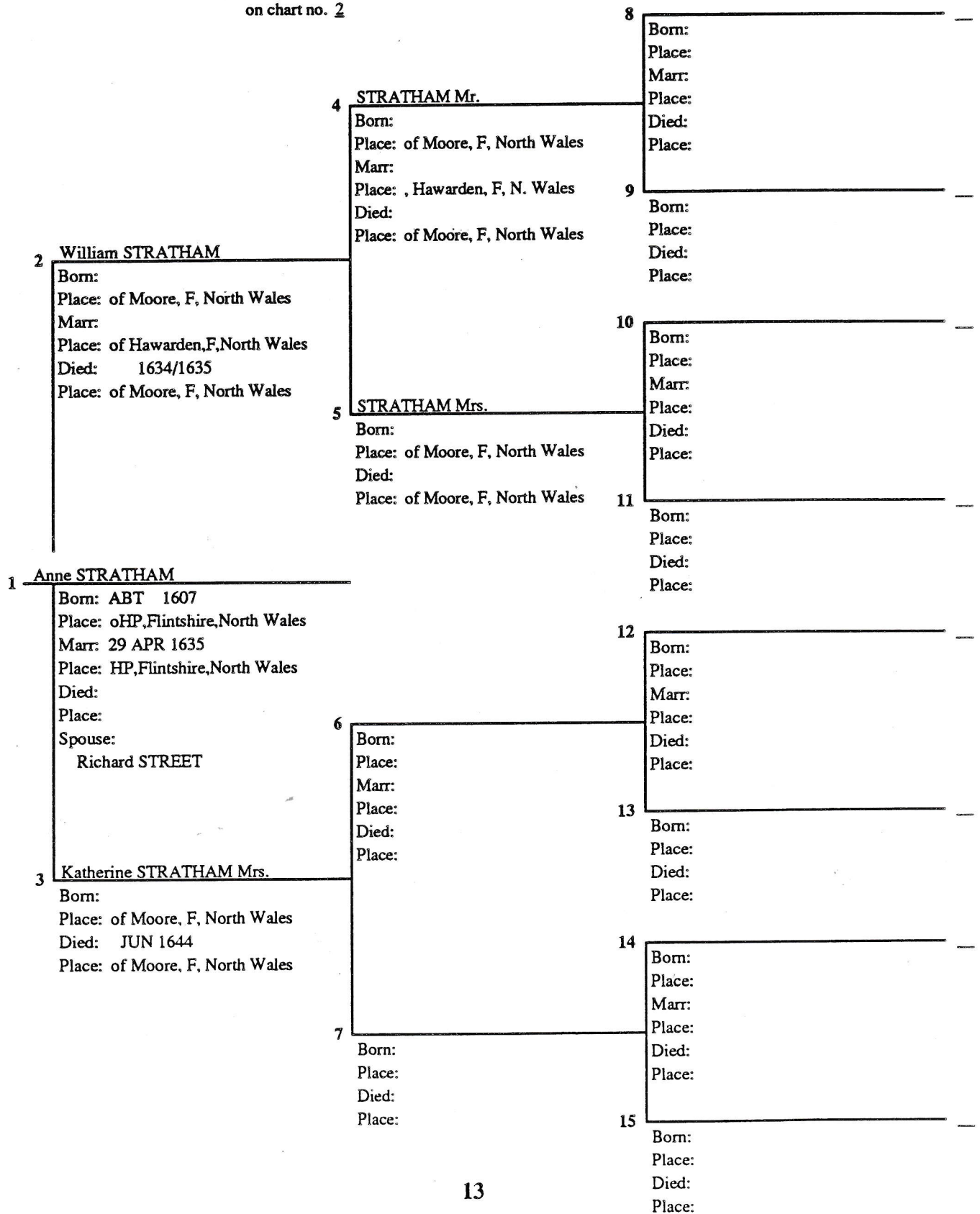
